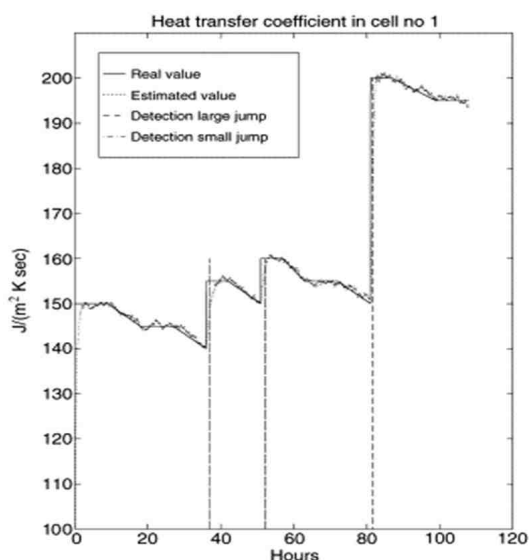


Fig. 1: Standard configuration (Times New Roman, 10pt, centered)
